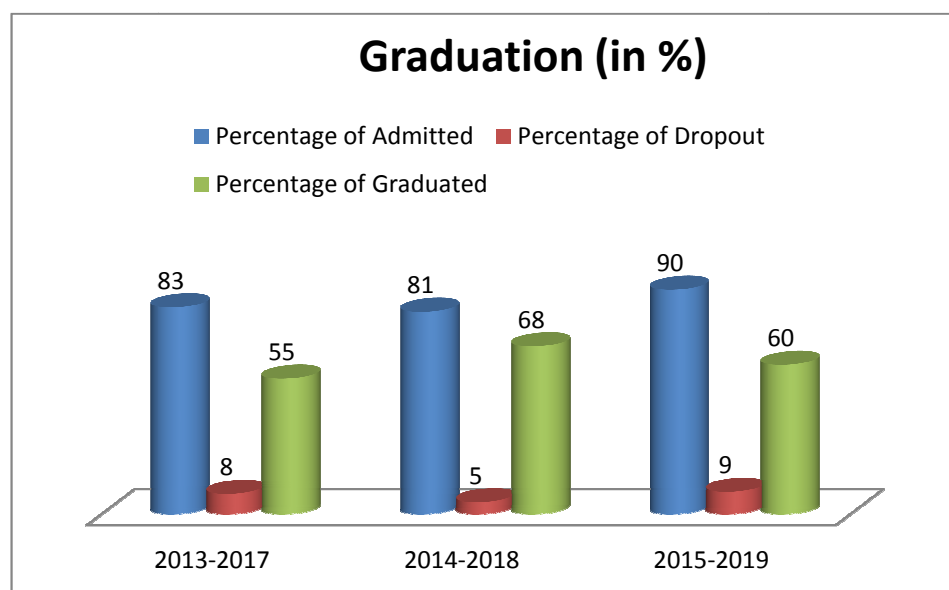


Figure 1: Graduation Statistics for three recent Batches

Under Curricular Aspects, he pointed out that all the programs follow Choice Based Credit System (CBCS) except B.Com and B.B.A. He shared the details of Teaching-Learning and Evaluation. While explaining about the pass percentage of students, Mr.Venugopal mentioned that it is always good to be strict in evaluation than students coming out with a mere pass. He further added Quality of engineers is very important. DA also agreed that the perception has been increased in recent years and a considerable increase in students' admission is evident.

DQA detailed out the Research, Innovations and Extension activities. 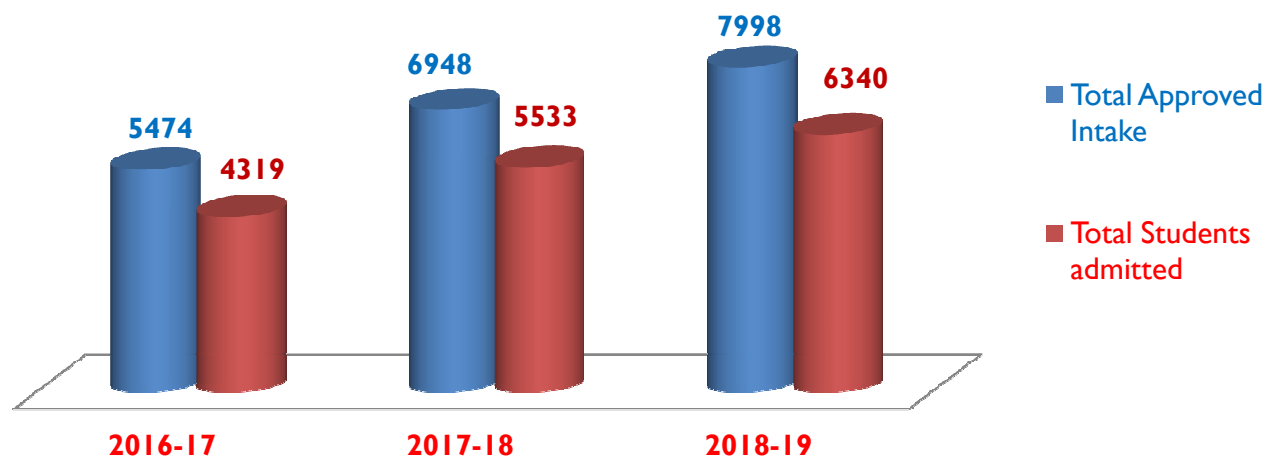

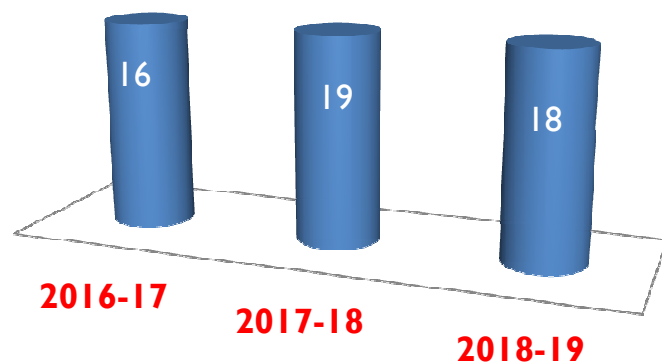

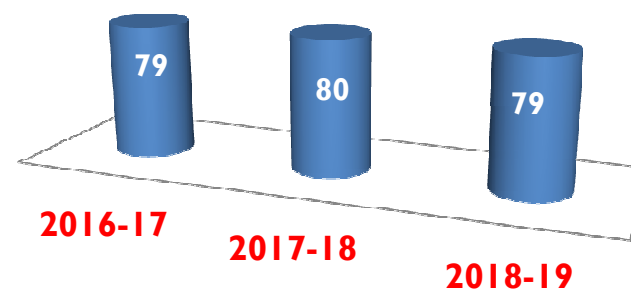
Sanctioned vs Admitted

Percentage of Enrolment

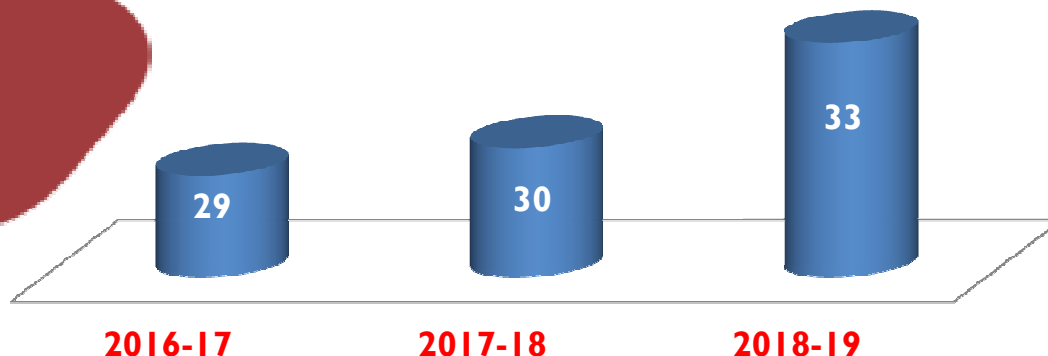

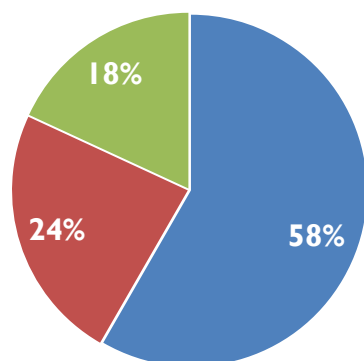

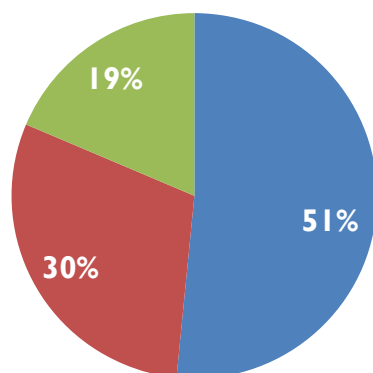


Percentage of Faculty with Experience

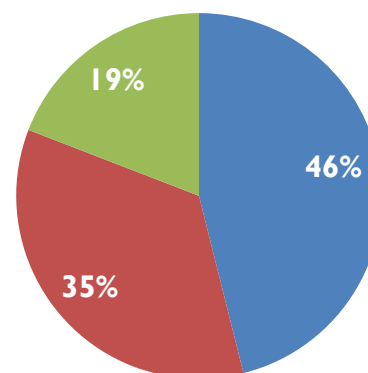
