- It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The programs have been granted provisional accreditation for 2 years. The Institute should submit the Self Assessment Report along with a compliance report at least after 1 year to be considered by the Engineering Evaluation and Accreditation Committee(EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendation of EEAC will be considered by the Sub-Committee of the Academic Advisory Committee and Executive Committee for decision.
- The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Vel Tech Rangarajan Dr. Sagunthala R&D Institute of Science and Technology, Chennai, Tamil Nadu as a whole. As such the institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously. Complete names of the programs accredited, level of programs and the period of validity of accreditation, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

- 9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
